How to apply

- 1. Interested candidates who fulfill the eligibility criteria should first register themselves (as a candidate) on National Apprenticeship Promotion Scheme 2.0 (NAPS 2.0) / National Apprenticeship Training Scheme 2.0 (NATS 2.0) portal as given below:
 - 1.1 Trade apprentices need to register themselves at National Apprenticeship Promotion Scheme 2.0 (NAPS 2.0) portal <u>"https://www.apprenticeshipindia.gov.in".</u>
 - 1.2 The Graduate Apprentice and Diploma Apprentice need to register themselves at National Apprenticeship Training Scheme 2.0 (NATS 2.0) portal <u>"https://www.nats.education.gov.in/"</u>.
 - 1.3 The candidate must ensure that, his/her Aadhar is seeded with Bank Account.
- 2. After registering there, candidates meeting the prescribed eligibility criteria for any post may submit the application form available at the NPCIL website <u>"www.npcilcareers.co.in"</u>. Before applying, the candidate shall ensure his/her eligibility for apprentice training. <u>The online application form will be available on the website from 13/09/2024 at 10:00 Hrs. and the online submission of application will be open until 03/10/2024 (16:00 Hrs.).</u>
- 3. Those candidates who have enrolled for apprenticeship on NAPS web portal <u>"https://www.apprenticeshipindia.gov.in"</u> or NATS web portal <u>"https://www.nats.education.gov.in/"</u> have to also apply for the following:
 - 3.1 Trade apprentice needs to apply for Narora Atomic Power Station, Nuclear Power Corporation of India Ltd. through the **Establishment Enrollment Identity No. E05200901473**.
 - 3.2 The Graduate apprentice and Diploma apprentice needs to apply for Narora Atomic Power Station, Nuclear Power Corporation of India Ltd. through the **Establishment Enrollment Identity No.** NUPBUC093592.

NOTE: The applications will not be accepted, if not applied in the respective Establishment Ids.

- 4. It is mandatory to upload following documents to complete the registration process and to get registration number:
 - 4.1 Birth certificate or 10th mark-sheet
 - 4.2 10th mark-sheet
 - 4.3 ITI/Diploma/Graduate Degree certificate, as applicable
 - 4.4 ITI/Diploma/Graduate Mark-sheets obtained in all Semesters/years, as applicable
 - 4.5 Residential Proof if living within 16 km Radius of NAPS, Plant Site.
 - 4.6 Caste Certificate, if applicable
 - 4.7 Valid Income and Assets Certificate, if applicable
 - 4.8 Disability Certificate, if applicable
- 5. Before applying online, candidates should have photograph in JPEG format, of size not more than 50KB and a minimum of 240 x 180 pixels and maximum of 640 x 480 pixels in dimensions and scanned signature in JPEG format of size not more than 20KB and a minimum of 80 x 200 pixels and maximum of 160 x 560 pixels in dimensions. The photograph should be in colour, with light coloured background, preferable white colour background and if candidates wear glasses make sure that there are no reflections and candidates eyes can be clearly seen.
- 6. Candidates are requested to make (keep) note of the login ID and password, as they will need this login ID to the website to check their application status from the website. An email will also be sent to the candidate with the application number, after completion of registration.
